Description of Change to the Customer:

Revision 01- Cortina Systems, Inc. (Cortina) is extending the Last Time Order Date to February 1, 2009 to give our customers additional time to determine their final Vallejo ceramic package requirements.

Original - Cortina Systems, Inc. (Cortina) is announcing the discontinuance of the HFIXF1104CE.B1 and WFIXF1104CE.B1 due to our ASIC vendor's EOL of the ceramic package type used by these devices. The recommended replacement part uses the same revision of silicon but with a plastic package. The replacement part is pin for pin compatible; however, the ball sizes are different, which means different BGA landing pads. Please see below for a list of products affected and the recommended replacement part numbers. Please note the key milestones listed above show the final order acceptance date at which time all orders become Non-Cancelable Non-Returnable.

Customer Impact of Change and Recommended Action:

Qualification and reliability data are available at the customer's request. Samples and production parts of the replacement parts are available and customers are requested to start the qualification process at their earliest convenience.
